FILTERED REPORTS

Before I start running all these reports I want to make sure you are aware of the potential risk of receiving "filtered" reports. When preparing a "filtered " report -- in order to give you a report for a specific date range (i.e., only matters currently open or closed less than 1 year ago), the Related Party section of the report is NOT included. This means that you will not be able to identify any "confidential" matters for which a party may be a client of the firm as they are not included in the standard report due to the terms of their retention. Basically, the entire Compass/Lexecon Division falls into this category.

I understand how cumbersome these reports can be for you and your staff, which is why "filtered" reports are certainly more convenient. I just want to make sure you realize that a potential "client of the firm" may be overlooked.

Please confirm that you want to run the reports as you indicated, which would only provide you with matters currently open or closed within the past year.
